SINGLE-FAMILY DWELLING BUILDING PERMIT SUBMITTAL REQUIREMENTS

GENERAL REQUIREMENTS FOR ALL PERMIT SUBMITTALS FOR SINGLE FAMILY DWELLINGS

- PLANS ARE REQUIRED TO BE LEGIBLE AND BE SUBMITTED AS EITHER BLUE PRINT PROCESS OR PHOTOCOPY.
- PLANS ARE REQUIRED TO BE WET SIGNED AND DATED IN INK BY THE PREPARER ON EACH SHEET PRIOR TO ISSUANCE.
- PLANS SUBMITTALS ARE REQUIRED TO INCLUDE THE SITE ADDRESS (JOB ADDRESS) ON THE FIRST SHEET OF THE PLANS.
- PLANS ARE REQUIRED TO BE DRAWN TO AN APPROPRIATE SCALE AND SIZE.
- PLANS THAT REQUIRE CALCULATIONS AND OR SPECIFICATIONS ARE REQUIRED TO BE WET STAMPED AND SIGNED BY A LICENSED PREPARER.

1. COMPLETE SITE PLANS (10 COPIES)

 A total of ten (10) copies of a complete site plan are required for which six (6) shall be attached to the building/construction plans and four (4) sets shall remain separate. See Complete Site Building Plans handout.

2. COMPLETE SETS OF CONSTRUCTION/BUILDING PLANS (6 COPIES)

• Six (6) copies of complete construction drawings and details are required for a project submittal of this type. The submittal will be forwarded, by the County, to all of the agencies necessary to review your project. **See Complete Set of Building Plans Handout.**

3. STRUCTURAL CALCULATIONS (2 SETS)

• Structural calculations and specifications are typically necessary for a submittal of this type. The submittals must be prepared by an authorized person, typically a licensed engineer or architect.

4. <u>TITLE 24 ENERGY CALCULATIONS (2 SETS)</u> (CALIFORNIA TITLE 24, PART 6 – CALIFORNIA ENERGY CODE)

Two (2) complete sets of energy calculations and forms are required for a project submittal of this type.

5. TRUSS CALCULATIONS (2 SETS)

Two (2) complete sets of truss plans and calculations are required to be submitted for a project submittal of this
type. Truss calculations may be submitted as a deferred submittal but before the erection of the trusses.
Truss plans to be wet signed by structural engineer of record.

6. GEOTECHNICAL REPORT (2 SETS)

· Geotechnical Report are required.

7. SOILS ENGINEER REVIEW LETTER (2)
